THE LAIKIPIA COUNTY FINANCE ACT, 2019

IN EXERCISE of the powers conferred by section 16 of the Laikipia County Finance Act, 2019 the Laikipia County Executive Committee Member for Finance makes the following Order:—

THE LAIKIPIA COUNTY FINANCE (AMENDMENT) ORDER, 2020

PART I—PRELIMINARY

Short Title

1. This Order may be cited as the Laikipia County Finance (Amendment) Order, 2020

Interpretation

2. In these Order, unless the context otherwise requires—

“County” means the County Government of Laikipia as established under Article 176 of the Constitution;

“County Assembly” means the County Assembly of Laikipia County;

“Executive Member” means the County Executive Committee member at the time being responsible for finance matters in the county.

Object and Purpose of this Order

3. The object and purpose of the Order is to—

- amend the schedules to correct glaring errors on the face of the schedules mainly those that reflect the county as discriminatory and impartial; and
- amend the Schedules to ameliorate the effects of the COVID-19 pandemic on the business community by maintaining the rates of revenue charges as charged by the last Finance Act in as much as the same is practically possible.

PART II—AMENDMENT TO THE SCHEDULES

Amendment to the First Schedule

4. The first schedule is amended as follows—

- by deleting part XIII-Cess for sale of meat outside the County in its totality.
- Part XXI is amended by deleting its title and substituting therefor the title ‘Cess Fees’
- Part XXIV is amended by deleting the words ‘and inspection fee’ where they appear in its title.
- The *Item description* ‘slaughter man’s license fee’ under Slaughter Slab inspection fee is amended by deleting the figure 2,000 as it appears as a charge for the year 2019/20 and substituting therefore the figure 600.

Amendment to the Third Schedule

5. The Third Schedule is amended as follows—

- Part IV—HOTELS WITH ACCOMODATION is amended as follows—

- deleting the its Title and substituting therefor the Title ‘TOURIST HOTELS PERMIT’

- deleting Item description ‘Hotels with Accommodation’ and substituting therefor the item as below: —

- deleting the figure 300,000 as it appears as a charge for the year 2019/20 under *Item description* ‘small’ and substituting therefore the figure 250, 000.
